

Global Commercial License Agreement

"This License Agreement (the 'Agreement') is entered into between the purchaser (the 'Licensee') and **The Graphic Vault Designs**, a sole proprietorship registered in Ötisheim, Germany, owned by Irina Svitkovskaja (the 'Licensor')."

1. Grant of License

The Licensor grants the Licensee a **non-exclusive, non-transferable, perpetual, worldwide license** to use, reproduce, and distribute the graphics, illustrations, and other assets included in the purchase (the "**Graphics**") solely in modified form for commercial and personal purposes. "**Modified form**" means the Graphics must be **substantially incorporated into a new, original design** (e.g., by adding elements, text, or altering the Graphic to create a derivative work).

2. Permitted Uses

The Licensee may use the Graphics for:

- Physical and digital products (e.g., apparel, posters, greeting cards, flyers, books, e-books, packaging, websites, presentations).
- **Explicitly excluded:** Use in trademarks, logos, or branding.

3. Sales Volume Limit

The Licensee may use the Graphics for products sold up to a **lifetime cap of 250,000 units**. Each product containing a Graphic counts as one unit. **Exceeding this limit requires an extended license.**

4. Large Companies

Companies with **more than 50 employees or annual revenue exceeding €1 million** must obtain a separate license from the Licensor for commercial use.

5. Prohibited Uses

The Licensee may **not**:

- Use the Graphics for extremist, pornographic, discriminatory, defamatory, or illegal purposes.
- Resell, redistribute, or sublicense the Graphics **in any digital form**, even if modified.
- Use the Graphics in **customizable products** (e.g., "on-demand," "made-to-order," or "build-it-yourself" offerings).
- Use the Graphics for **AI training, dataset creation, or machine learning purposes**.
- Claim ownership or copyright of the original Graphics.

6. Intellectual Property

The Licensor retains **all rights, title, and interest** in the Graphics. The Licensee does not acquire any ownership rights to the original files or Graphics.

7. Termination

This license **terminates automatically** if the Licensee breaches any terms. Upon termination, the Licensee must **immediately cease all use** and destroy all copies of the Graphics.

8. Governing Law and Jurisdiction

This Agreement is governed by and construed in accordance with the laws of **Germany**, without regard to its conflict of law principles. **Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of the Federal Republic of Germany**, regardless of the Licensee's domicile or place of business. The parties expressly waive any objection to these courts based on inconvenience or forum non conveniens.

9. Liability and Warranty

The Graphics are provided "**as is**". The Licensor makes **no warranties** regarding their suitability. The Licensor is not liable for any damages arising from their use.

10. Severability

If any provision is found invalid, the remaining provisions remain enforceable.
